1. That the undersigned will have the aforesaid \_\_\_\_\_ Forthcoming before the court named in sad bond, attached hereto, at the time therein fixed and from day to day and term to thereafter, as may be ordered by the said court.
2. That the undersigned will at all times indemnify and saved SURETY or its Agent, harmless from and against every and all claims, demands, liability, cost charge, counsel fee, expense suit order, judgment or adjudication whatsoever which the said SURETY or its agent shell or may for any cause at any time sustain or incur by reason or in consequence of the sad SURETY having executed said bond or undertaking, will upon demand, place the said SURTY or its Agent in funds to meet every claim, demand, liability, cost, charge, counsel fees, expense, suit order, judgment or adjudication against it by reason of such suretyship, and before it or its Agent shall b/e required to pay this same.
3. The condition of sad indemnity, Agreement provides that as long as there is any liability or loss of any nature whatsoever to the SURTY upon the bond referred to herein the undersigned will not make any transfer. Or any attempted. transfer of any of the property ,real or personal given as security or witch the undersigned may subsequently acquire or any interest therein and it is further agreed that the SURETY or its Agent shell have a lien upon all property of the undersigned for any sums due to it has become, or may become liable by reason of its having executed the bond referred to herein.
4. The voucher or any others evidence of any payment made the sad SURETY or its Agent by reason of such surety ship, shall be conclusive evidence of such payment against the undersigned and the undersigned's estate both as to the property thereof and as to the extent of the liability thereof to the said SURETY.
5. That the SURETY or its Agent, may withdraw from its surety ship upon said bond or unmarking at any time that it may see fit, as provided by law.
6. That the agreement shall not be retuned by the sad SURETY or its Agent, at the time it shell be satisfied of the termination of it liability under said bond or obligation, but shell be retained.
7. That failure of any of the undersigned to comply with the provisions of this indemnity Agreement shall be binding upon the others.
8. If any provision or provisions of this instrument be void or unenforceable under the law of any place governing its construed and endorsed with the same effect as though such provision were omitted.
9. Indemnitor (s) hereby authorize (s) any person, agency, partnership or corporation having any information concerning my character and release such person, agency, partnership, or corporation from liability which may be incurred in releasing to the SURETY, its assigns and /or duty authorized representatives.
10. I hereby waive any and all rights I may have under tattle 28 Privacy Act- Freedom of Information Act Title 6, Far Credit Reporting, Act, and such local or state law. I consent to and authorize the SURTY, and /or its agent, to obtain any and all private or public information and/or records concerning me from any part or agency, private or government (local state federal ) including but not limited to social security records, criminal records civic record, driving records, telephone records, medical records school records compensation records & employment records. I authorize without reservation, any party or agency, privet or government (local, state ,federal ) contact by the SURETY and/or its Agent to furnish any and al privet and public information and records in their possession concerning me to the SURETY, and /or its Agent for good and valuable consideration, under the undersigned principal agrees to indemnify the SURETY company or its agent for all losses no otherwise prohibited by law or rules of the Department of Insurance .
